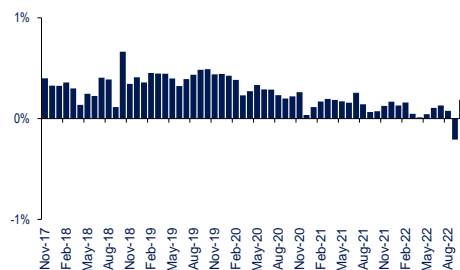

Monthly Returns during the Last 5 year

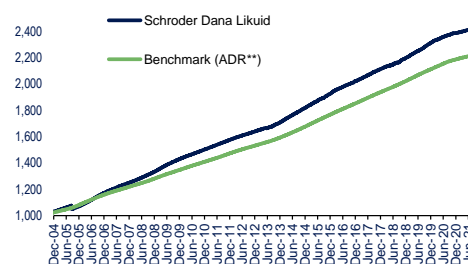
